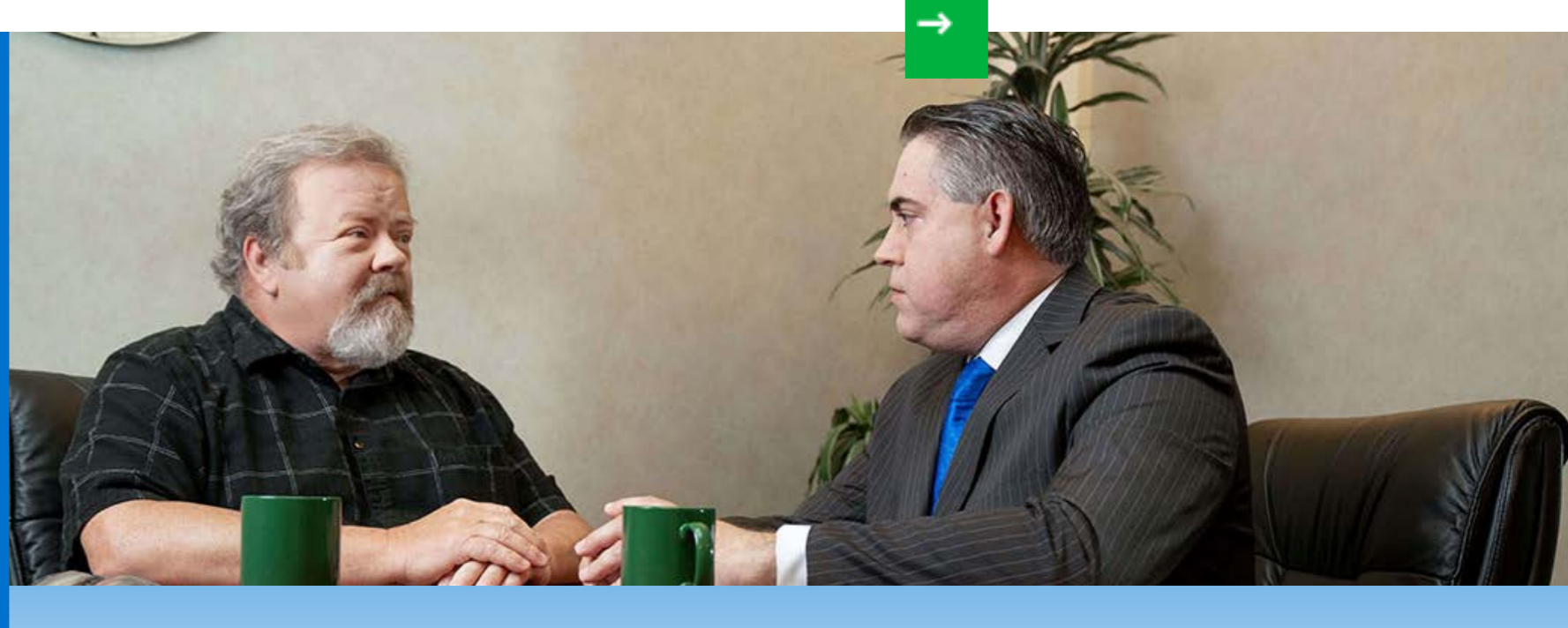

HOW DOES MY PERSONAL INJURY CASE WORK?

When you were hurt in a car wreck, a truck wreck, a slip and fall on someone's property, a dog bite, or another personal injury situation, your case could go through these steps:

Step 1: Investigation

An HNB attorney will gather police reports, statements from witnesses to your injury, and other evidence. Your attorney will make sure you're getting the medical treatment you should.

Step 2: Starting a Personal Injury Claim

Your attorney negotiates with the negligent party or their insurance company. They consider whether it looks like you'll need ongoing care or whether your injury will leave a permanent disability. You could seek compensation for your direct medical and property costs, lost wages when you can't work, pain and suffering you've endured and more. You could reach a settlement agreement for fair payment.

Step 3: Filing a Lawsuit

If you can't agree on a settlement with the responsible party, your next step is to file a lawsuit. You'll need an experienced personal injury lawyer to take care of all the legal technicalities involved with filing suit.

Step 4: Gathering Information for Your Lawsuit

Lawsuits start with a process called "discovery," which involves trading questions and answers with the opposing group and giving statements under oath called depositions. This is a crucial step in establishing your case. Sometimes this is when people agree on a settlement.

Step 5: Going to Trial

Most cases don't get this far. But if it's the only way to get full compensation for your pain and losses, you need a lawyer willing to go to trial. And you need a lawyer to present your arguments to the judge or jury.
