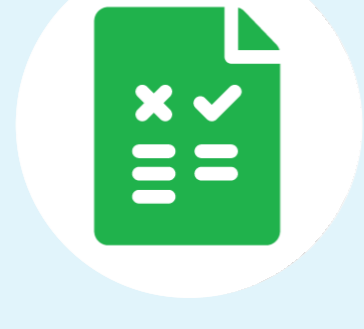

Veterans can receive disability benefits for anxiety, bipolar disorder, depression, effects of military sexual trauma (MST), PTSD, dementia and more.

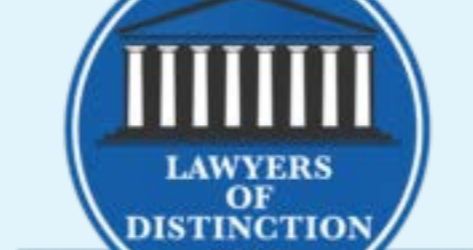
